Organ masterclass

The application for registration in the **Organ masterclass** of the 54 Manuel de Falla Courses implies the acceptance of these conditions of participation.

The organization of the Manuel de Falla Courses reserves the right to modify any of the contents of this master class. Any changes will be announced at the time of their occurrence, on this website. The organ masterclass may be cancelled in the event that only one student has enrolled the masterclass.

1. Applications for registration

They can be submitted exclusively online on this website, by completing the registration form and attaching the required documentation. Applications for registration not accompanied by all the required documentation, or those that are received outside the established registration period, will not be accepted.

2. Fees payment

Any expense generated by the banking operations will be borne by the applicants.

Fees refund

In the case of justified resignation of the student, 80% of the tuition fee can be refunded, provided that such refund is requested in writing, and at least **10 days** before the start of the master class. **Outside this period, no refund request will be met.**

The organization will only refund the full amount paid in case of cancellation, change of dates or total modification of the program or contents of the activity.

3. Scholarships

Scholarships covering tuition fees may be applied for by active students. Applicants must request it when completing the application form and the following documentation must also be provided:

- A photocopy of the Tax Return form of the applicant and the members of his/her family

unit (even though the applicant may no longer be under their responsibility) applied to the last tax year.

- A photocopy of the applicant's academic certification together with the grades obtained and, if relevant, any other artistic or professional certificates.

The award of scholarships will be the responsibility of the Evaluating Committee of the Festival Internacional de Música y Danza de Granada. The Committee's resolution will be final.

Those applications not including the documentation required above will not be met.

The award of scholarships implies the obligation to attend the whole activity. No absences will be admitted, except those properly justified. Non-fulfillment of this obligation may be cause of revocation of the grant.

4. Places

3 active students

Applicants must indicate in the registration form a link to a video (YouTube, or similar...) with good quality of image and sound, of 5-10 minutes duration, including a recent performance. They must also attach a short CV outlining studies and courses they have undertaken, concerts they have performed at, etcetera. Applicants are also kindly requested to indicate in their applications, the repertoire they will perform during the class. Selection will be made by Mr. Koopman and the organization will notify successful applicants by e-mail.

Observers are welcome according to the capacity of the church. Places will be covered by order or reception of applications (which must include a curriculum). Successful applicants will be notified by e-mail.

5. Recording and communication

Participants in the masterclass authorize the organization of Manuel de Falla Courses to take images and to make audio recordings and / or videos of the class, as well as the distribution in any medium or non-venal sound or audiovisual support of said recording, for archiving, promotion, and dissemination purposes.

6. Liability

Manuel de Falla Courses decline all responsibility for accident of the participants in the masterclass except in the case that the accident has been directly caused by a negligence attributable to the Courses. The organization declares to have subscribed all the Insurance Policies intended to cover the civil liability of the activities organized.

7. Personal data protection

All personal data provided by the applicants will be protected by the Spanish and European laws of protection of personal data.

8. Certificate of participation

Participants who prove attendance at the masterclass will be able to obtain a diploma and a certificate of attendance, which will have to be requested in writing addressed to cursos@granadafestival.org. The certificate will be sent by e-mail.

9. Accommodation

Information on accommodation in Granada will be provided to those students who request it. Those interested must formalize their reservations directly with the chosen establishment.
